

**SHOW CAUSE NOTICE FOR COMPULSORY DELISTING**

Notice is hereby given that Delhi Stock Exchange Limited is proceeding for compulsory delisting of the securities of companies listed below as per Regulation 22 of Chapter V of SEBI (Delisting of Equity Shares) Regulations, 2009. You are requested to take note that as per the stipulations made in the Regulation 24 of the SEBI (Delisting of Equity Shares) Regulations, 2009 once a company has been compulsorily delisted, the company, its whole-time directors, its promoters and companies which are promoted by any of them shall not directly or indirectly access the securities market or seek listing for any Equity Shares for a period of ten years from the date of such delisting.

Keeping in view of the grave consequences of the compulsory delisting, the Exchange hereby advises the companies to make a representation before the undersigned showing cause why their securities should not be compulsorily delisted.
